Changes to accessing Supplier Release Notes

We will have our next Product Release, 21.3, on November 15th. As usual, once this Release is available, you will be able to access the Supplier Release Notes that provide details about any changes / additions to JAGGAER Supplier Portal functionality or the JAGGAER Procurement Applications that are relevant to the suppliers. However, moving forward, you will need credentials to access the Supplier Release Notes. The credentials will be made available in your JAGGAER Supplier Portal. The November issue of the SupplierNews, which will be sent a week before the 21.3 Release is available, will have the details about it.

Main features of interest for the 21.3 release include:

- Ability to filter sales orders by Order Acknowledgement or Advanced Shipping Notice status.
- Several minor enhancements to invoices and credit memo creation.
- The ability for customers to assign a Questionnaire to a specific supplier portal user

Maintaining JAGGAER Supplier Portal Users

The JAGGAER Supplier Portal provides ability to assign specific permissions to users so that you can regulate access of relevant Portal functionality for the users. A set of permissions are associated with a 'role' and so by assigning such role, you can readily control multiple permissions for a user. Here are some best practices to manage Portal users;

1. Ensure that only appropriately qualified personnel within your organization have access to requisite functionality such as editing hosted catalogs, responding to RFx events posted by customers etc. Adjust at the level of specific permission or at role level
2. Be sure to inactivate users who no longer need to have access to your JAGGAER Portal
3. SupplierNews is sent to active users in the Portal. So if needed, create a user in your Portal so that he/she can receive SupplierNews mailings
