IMPORTANT: Security Certificate Update

Please direct this request to your IT team(s) responsible for maintaining integrations between your organization and JAGGAER. Failure to evaluate/take action might adversely affect your integration points with the JAGGAER Procurement Application.

JAGGAER's Certificate Authority (CA), GlobalSign, requires that server security certificates are renewed each year. JAGGAER's server security certificate will be replaced on 12/11/2021 beginning at 6:00 PM EST, during JAGGAER's standard monthly IT maintenance window. The new, replacement certificate is now available for download as indicated below.

IMPORTANT: Action is needed if you use integration such as Advanced Shipping Notification (ASN) via cXML or send Invoices/Credit memo etc to the JAGGAER Procurement Application. **If you are not sure whether you will be affected, please have your IT team contact our Supplier Support group using contact information provided at the end of the newsletter.**

This change will impact both UIT and Production as well as any other connections to the *.sciquest.com domain. If your organization already trusts GlobalSign's root CA, no action is necessary.

- **Both UIT and Production will be updated on Saturday, December 11th from 6:00 pm EST - 11:00 pm EST**

If your integrated systems are able to maintain multiple security certificates, concurrently, please install the updated certificates as soon as possible. Failure to download and install the new trusted certificates prior to the above dates may lead to integration failures with JAGGAER until the updated certificates are installed and trusted.

Accessing Supplier Release Notes for 21.3 Release

Our latest Product Release. 21.3, will be available starting this Sunday, 14th November and will include enhancements related to sales orders, invoices etc. As usual, the Supplier Release Notes will have the details about new as well as enhanced functionality. While Supplier Release Notes are available in the same location on the Product Release Library, you will now need credentials to access the library content. The credentials are displayed on the **Welcome page** of the online searchable help in the Supplier Network Portal.

Once logged into Portal, click **Browse the Table of Contents** in the **Need Assistance?** widget on the Supplier Network Portal Home Page. The Welcome page of the online help displays in an overlay. Note the link for Supplier Release Notes under 'Additional Resources'. Once the 21.3 Release is available, the required credentials that you will need for accessing the Release Notes will display there. You will also need to use these credentials to access the Data Completeness Report Overview document referenced in the first topic in this newsletter about DCRs.
